

## Privacy policy

This Privacy Policy is intended for persons who use the information provided in the TASTE KEEPERS Facebook group page (hereinafter - the Group page); communicate on the Group page; participate in organized trainings, seminars, and beverage tastings, and otherwise use the Group page. The Privacy Policy describes the purposes of processing personal data, the scope of personal data, the rights of data subjects, and other information regarding the processing of personal data.

The account Data manager is 'UAB Mineraliniai vandenys' with legal entity code 121702328 and registered office address Aukštaičių str. 7, Vilnius, Lithuania (hereinafter - the Company or We).

### General provisions

**Only after submitting personal data specified on the Website <https://mvgroup.eu/distribution>, in the Rules for the Use of Informational messages on alcoholic beverages for "Taste Keepers" and as required by law, admission to the Facebook group "Taste Keepers" will be considered and decided on a case-by-case basis. If the administrator of the Group decides that the data provided by the person in the Rules for the Use of Informational messages on alcoholic beverages for "Taste Keepers" indicate that the person may be a member of the Group, such person will be able to become a member of the Facebook group "Taste Keepers."**

By registering and agreeing to the processing of your personal data for the purposes of registration and administration of the 'Taste Keepers' Facebook group account in the Informational messages section of the registration form, you confirm that you have read and understood the Privacy Policy, agree to it, and agree to comply with it.

Please note that personal data and any other information you post on the Group page is also visible to other members of the Group, so before publishing any personal data or any other information, please check that it does not contain any offensive content or any other content that breaks the law and/or infringes on the rights of members of the Group or visitors. In any case, we reserve the right to remove any information posted to the Group if it violates the law or the rights of other members of the Group or visitors.

### Basic information about personal data processing

We understand the importance of personal data protection. Therefore, we respect and protect the privacy and personal data of the Group's visitors. We collect and process personal data per the requirements of the EU and Lithuanian legal acts regulating the protection of personal data.

Data from the Group's visitors is processed on the following basis:

- *on the basis of consent*, which is expressed by your active actions when you provide personal data in order to register with the Group, comment, respond, and/or share messages and information in our Group;
- on the basis of the implementation of legitimate interests when we administer the Group, seek to ensure the proper functioning of the Group, and ensure the protection of your personal data;
- on the basis of compliance with legal requirements when we perform the obligations imposed on us by law.

The Company seeks to ensure that personal data is processed accurately, fairly, and lawfully, that it is processed only for the purposes for which it was collected, and that it is processed in accordance with clear and transparent principles and requirements for the processing of personal data.

#### **Transfer of personal data to third parties**

The Company will not voluntarily share the personal data you provide to us without your prior consent with any third party, except where we have to comply with legal requirements or protect legitimate interests. In this case, the data may be provided to public authorities, such as the police or supervisory authorities, to protect our or our customers' rights or the safety of employees and resources, or to defend our rights or comply with legal requirements.

#### **Processing of personal data by Facebook**

We would like to inform you that when you visit the Group page, your browser and/or mobile device establishes a direct connection with the Facebook server, which installs cookies and plugins for you. Facebook, in turn, collects information about your actions in the Group: what messages draw your attention, what sections you view most often, what you're looking for, and other information. You also have the right to demand that the data manager restricts the processing of personal data or the right to transfer data, submit a complaint to the State Data Protection Inspectorate (contact details are available on the website [www.ada.it](http://www.ada.it)), and not consent to the processing of submitted personal data. #### **Data transfer**

All personal data provided by you is processed in the territory of the European Union. However, please note that the data collected by Facebook is shared globally between Facebook companies and partners.

Information held by Facebook Ireland Limited (legal entity code 462932, registered office 4 Grand Canal Square Grand Canal Harbor Dublin 2, Ireland) may be transferred, forwarded, stored, or processed in the United States or other countries as described in the Facebook Privacy Policy.

According to the information published in the Facebook Privacy Policy, Facebook Ireland Limited uses standard contract terms for data transfers, which are approved by the decisions of the European Commission on data transfers from the EEA to the United States and other countries.
