

Rules for the use of 'Taste Keepers' messages on alcoholic beverages

General terms

Informational messages on alcoholic beverages from 'Taste Keepers' (hereinafter - Messages) is a system for storing and submitting messages solely aimed at professional alcohol specialists on the 'UAB Mineraliniai vandenys' website and a special Facebook account.

The messages are intended to be used solely by professional alcohol specialists whose job roles and responsibilities or other activities are related to the purchase and sale of alcoholic beverages or other activities related to alcoholic beverages.

Informational messages on the 'UAB Mineraliniai vandenys' website and a special Facebook group will provide information on the history of the production of alcoholic beverages distributed by 'UAB Mineraliniai vandenys,' production technologies, raw materials used in production, taste profiles of beverages, awards given to beverages at international exhibitions, global ratings, and information on pairing drinks with food, as well as tips on serving and presentation, recipes for famous alcoholic cocktails, new cocktails around the world, and other information about alcoholic beverages.

Users of these messages must comply with the Rules for the Use. Users wishing to receive separate access to the Informational Messages published in the special Informational Messages of the Facebook group must agree to and comply with the following requirements:

Usage restrictions

The users of informational messages in the special Facebook group may only be persons over the age of 18 and whose job roles and responsibilities under their employment contract or other activities are related to the purchase and sale of alcoholic beverages or other related work.

Access to messages on the special Facebook group will only be granted to individuals who confirm their age, job description, or description of other activities, workplace or other activities, e-mail address, and telephone number.

Access to the messages on the Facebook group will only be granted to individuals who agree to the privacy policy on processing personal data for the purposes of registration and administration, as well as observing the rules.

Sharing the informational messages with other persons is forbidden, as they are intended for and made available to only registered members of the special Facebook group.

Facebook group communication

To ensure polite, smooth communication in the Facebook group, the following provisions will be mandatory for members of the group:

- You may only share your videos, photos, and other content (if not restricted) if it is your own intellectual property. You are personally responsible for the content of the posted message;
- Publishing personal data or information of other natural or legal persons (any personal data, bank account numbers, telephone numbers, passwords, etc.) on the group page is not permitted;
- Posting the following comments or posts in the group is not permitted:

obscenities,

offensive words;

discrimination, inciting hatred based on gender, race, age, ethnicity, etc.;

Slander and abusive speech;

information of an advertising nature, encouraging the donation or transfer money, illegal downloading not related to a discussion topic;

threats, intimidation, or promotion of illegal activities; comments of offensive or commercial nature;

breaching the requirements of the laws of the Republic of Lithuania.

Comments or posts that do not comply with these rules will be removed, and individuals who post such comments or posts may be removed from the Facebook group.

UAB Mineraliniai vandenys is not responsible for the content published by the members of this Facebook group or on the pages or accounts to which the members of the group provide links.

Passing data to others

Informational messages may only be used for business purposes, work functions, or other activities related to alcoholic beverages.

Information messages may not be copied and/or distributed to other persons in any way.

Persons wishing to use the data for other purposes must apply in writing for access to specific data. Persons who do not comply with the restriction on copying and/or distributing data contained in the Informational messages shall be personally liable under the laws in effect in Lithuania.

Final Provisions

The rules may be changed with 15 days of advance notification and publication of the changes on the 'UAB Mineraliniai vandenys' website.
